USEFUL TIPS

- Luggage: Please bring <u>soft shell luggage</u> instead of hard shell suitcases. They are easier to be stored and they do not make any scratches in the interior of the boat.
- Tipping: customary crew gratuity ranges between <u>5% to 15%</u> at Charterer's discretion.
- Bring light clothes, and enough swimsuits. Please bring your travel adapters if you are coming out of the EU, Note <u>high heels</u> are *forbidden* on board.
- Drugs and other illegal activities: please note that the vessel operates a zero-tolerance policy and that the possession or use of any illegal drugs (including marijuana) or any weapons is <u>strictly prohibited</u> on board. Failure to comply shall be enough reason for the Owner to terminate the Charter forthwith without refund or recourse against the Owner, Stakeholder or Broker.
- Itineraries: Depending on the winds, sailing conditions might be rather challenging. The itineraries sent beforehand are <u>only</u> <u>suggestions</u>. The final itinerary will be decided upon arrival and based on current weather conditions. <u>Safety comes first.</u>
- Please send us a copy of all passenger's <u>passports</u>.

Note: <u>PASSPORTS or Valid ID</u> cards ARE REQUIRED BY LAW FOR ALL MEMBERS OF YOUR CHARTER PARTY
